2023 Overall Rankings

The Best Places to Work in the Federal Government[®] rankings and accompanying data provide a way to hold federal leaders accountable for the health of their organizations, shining a spotlight on agencies that successfully engage employees and on those that fall short.

The data provides leaders with a roadmap to better manage our government's most important asset—its employees. Best-in-class private sector organizations understand that increased employee engagement and satisfaction lead to better performance and outcomes. Federal leaders need to follow suit by placing a greater emphasis on improving their workforce and workplace culture.

The government-wide Best Places to Work employee engagement and satisfaction score for 2023 is 65.7 out of 100, a 2.3-point increase from 2022. This represents the first increase in employee engagement and satisfaction since 2020, when the federal workforce began dealing with disruptions caused by the COVID-19 pandemic.

While uncertainties remain, some sense of normalcy and stability developed in 2023, with many workers adjusting to the new realities and agencies continuing combinations of in-office, hybrid and full-time telework. The improvement in the government-wide and agency scores may also reflect the Biden administration's increased focus on employee engagement and satisfaction.
